#### International Restricted Tender procedure following publication Ref. No.

The tender procedure is based on the IADSA Guidelines for the Project Implementation as well as on the law for "Public Procurement" no. 9643 date 20.11.2006 as amended, for what not specified in the IADSA GPI. The procedure is an international restricted tender procedure following publication. The Service Contract subject of the tender is: "STUDY AND PROJECT DESIGN FOR THE URBAN REHABILITATION AND THE ARCHITECTONIC RECONSTRUCTION OF BUILDING FACADES ALONG THE MAIN AXES OF THE PILOT ZONES" a subcomponent of the project: "DETAILED STUDY FOR THE RECONSTRUCTION AND ARCHITECTURAL REHABILITATION OF THE EXISTING BUILDINGS, IN ORDER TO CREATE A UNIQUE ENSEMBLE BASED ON THE TRADITION OF THE LOCAL ARCHITECTURE."

The Evaluation Commission, composed by Ms Ariela Kushi, Mr Elton Rondo and Mr Kostaq Kreku on the first phase had shortlisted four companies: Atena Studio Srl & Atelier 4 Ltd, A.R.S. Progetti S.p.A., Progin S.p.A, C.E.C. Group Ltd.

These shortlisted companies were invited to submit a Technical and a Financial Proposal.

On the scheduled delivery time (June 08, 2015) only Atena Studio Sr I& Atelier 4 Ltd and C.E.C. group Ltd had delivered their bids.

The envelops were sealed and opened at the scheduled public opening to verify that the technical and financial proposals were submitted in separated sealed envelopes. The

opening was done in the presence of the companies' representatives. A separated statement was keep and signed by all the participants.

The Evaluation Commission members had analyzed individually the technical proposal and had submitted their evaluations, part of this Statement.
